HONOURS and AWARDS UPDATE ON PRESENTATION OF PINGAT JASA MALAYSIA

Sometime ago information was published dealing with the proposed award by the Malaysian Government of the Pingat Jasa Malaysia (PJM), to those members of the Australian Defence Force who served in prescribed areas from 31 August 1957 to 12 August 1966, or to 9 August 1965 for service in Singapore. On Monday, 30 January 2006 the Malaysian Chief of Defence Force, Admiral Anwar attended Government House, Canberra to present the first awards of the PJM.

The original intention was for the medal to be presented individually at small ceremonies around the country, and in Malaysia to visiting Australians. However, this is now no longer possible. Distribution to remaining eligible recipients will now be through the Directorate of Honours and Awards from within Defence, acting as agent on behalf of the Malaysian Government. The process is expected to commence in the near future.

THE AUSTRALIAN DEFENCE MEDAL

Her Majesty the Queen recently approved the Regulations and letters patent for the medal. It is expected that the medal will be available for presentation in mid 2006. The Australian Defence Medal (ADM) has been established to recognize Australian Defence Force(ADF) Regular and Reserve personnel who have demonstrated their commitment and contribution to the nation by serving for an initial enlistment period or four years service whichever is the lesser.

Application for the Australian Defence Medal Guidelines for completion

The Australian Defence Medal (ADM) has been established to recognise serving and former Australian Defence Force (ADF) Regular and Reserve personnel who have demonstrated their commitment and contribution to the nation by serving for at least four years, or, completion of their initial term of engagement, whichever is the lesser.

Who is eligible?

In addition, eligibility for the ADM will be extended to ex-service personnel who:

- · have died in service;
- have been medically discharged with a compensatory impairment at the time of their discharge, thus rendering them unable to serve the required minimum qualifying period; or
- have honourably served but, due to some Defence workplace enlistment policies of the time (as determined by the Chief of the Defence Force), were unable to serve the required minimum qualifying period.

Documents required for verification of service

All applications for the ADM will need to undergo a verification process to ensure that all information provided is true and correct. This process will be greatly assisted by applicants providing documentation that verifies all service in the ADF. Certified true copies (no originals please) of documents will be accepted as proof of service, eg:

- Certificate of Service
- Certificate of Discharge
- · Extracts of service records
- Details of any Long Service Awards received.

These documents should be certified by a Justice of the Peace or other authorised person (see Certification of Documents page). Please note that if these documents are NOT provided, there may be significant delays in assessing the application.

If an applicant does not have supporting documentation, the Directorate of Honours and Awards (DHA) will check applicants service records to verify an entitlement (or otherwise) to the ADM.

Information for those with Reserve service

Members of the Reserves (serving and ex-serving) will need to supply supporting documentation with their application. They may provide documentation signed by their unit Commanding Officer that certifies their service as efficient and in line with the medal regulations. Please note that failure to do so will mean the applicant may incur lengthy delays due to the amount of manual checking required to verify Reserve service.

Non-Effective Service

Non-Effective Service of 21 days or more will not be counted towards the ADM, as will any other Non-Effective Service as determined by Defence policy. Normally, only service rendered under Defence conditions of service and remunerated at Service rates of pay may be taken into account as qualifying service for awards awarded by time. Service in the Standby Reserve or Ready Reserve where no training commitment applies will not be taken into account as qualifying service.

Application forms for further medal entitlements

The application forms for the ADM can only be used to apply for the ADM. All other medal applications must be made separately.

Application forms for the Anniversary of National Service 1951-1972 Medal, the Pingat Jasa Malaysia, and the generic application form (for all other service medals and long service awards) can be obtained by calling the DHA on 1800 111 321, or can be downloaded from the Honours and Awards website at the following link:

Completing the Australian Defence Medal application form (Form AD 497)

- Please use BLOCK letters only.
- · Some fields on each form are mandatory and must be completed as appropriate.
- Please complete the entire form and provide details of ALL ADF service, and provide documents to verify service.
- There is enough room for listing two separate periods of mixed service on the form; if more room is needed, attach additional pages. This is in relation to service in two or more arms of the ADF.
- Applications will be processed in order of receipt and are subject to verification by the Department of Defence. However, applicants who do not include documents to verify service will experience delays with their application.
- Please attach certified true copies (no originals please) of Certificate of Service or Certificate of Discharge etc.
- Posthumous and unclaimed Medals or Awards for deceased ex-serving members will be issued to the beneficiary of the estate
 of the deceased member.
- The application form (AD 497) must be witnessed and certified by a Justice of the Peace or other authorised person.

Fraudulent claims

Persons who submit fraudulent applications based on a statutory declaration may be subject to prosecution under Section 11 of the Statutory Declarations Act 1959 as amended, which states in part that:

A person must not intentionally make a false statement in a statutory declaration.

Penalty: Imprisonment for 4 years.

Falsely claiming entitlement to the ADM, and then subsequently wearing the award, is an offence under Section 80B of the Defence Act 1903- Improper use of service decorations. This offence is also punishable by fine and/or imprisonment.

Certification of Documents

Posthumous applications

Posthumous applications for the Australian Defence Medal (and other medals) will only be considered from the following:

- (a) Executor of the Will of the deceased member
- (b) Public Trustee Administrator appointed by the State in cases of intestacy
- (c) A person who can provide legal proof to their status as the sole beneficiary to the claim being made for posthumous issue of the Service award(s) (if such proof cannot be tendered, the entitlement remains unclaimed and may lapse).

Please note that Statutory Declarations, birth certificates or marriage certificates tendered in isolation do not equate to legal proof of your beneficiary status.

Examples of acceptable legal proof are as follows:

- A letter from a solicitor identifying you as the Executor of the estate or Public Trustee Administrator in the case of intestacy
 of a deceased members estate;
- · A Certified True Copy of the Will (or extract thereof) identifying you as sole beneficiary to the deceased person's estate; or
- A letter from your solicitor stating that you are legally the sole beneficiary.

A Justice of the Peace or other authorised person must certify current and posthumous ADM application forms (AD 497), as well as documents provided as proof of service for applications. A Statutory Declaration under the *Statutory Declarations Act 1959* as amended may be made before:

- Dentist
- Legal practitioner
- Medical practitioner
- Nurse
- Pharmacist
- Veterinary surgeon
- Agent of the Australian Postal Corporation who is in charge of an office supplying postal services to the public
- Australian Consular Officer, or Australian Diplomatic Officer, (within the meaning of the Consular Fees Act 1985)
- · Building Society officer with five or more years of continuous service
- Chief Executive Officer of a Commonwealth court
- · Clerk of a court
- · Commissioner for Affidavits
- Commissioner for Declarations
- Bank Officer or Credit Union Officer with five or more years of continuous service
- Holder of a statutory office not specified in another item in this list
- · Judge of a court
- · Justice of the Peace
- Magistrate
- Marriage celebrant registered under Subdivision C of Division 1 of Part IV of the Marriage Act 1961
- Member of the Australian Defence Force who is an officer; or a non-commissioned officer within the meaning of the Defence
 Force Discipline Act 1982 with five or more years of continuous service; or warrant officer within the meaning of that Act
- Member of the Institute of Chartered Accountants in Australia, the Australian Society of Certified Practising Accountants or the National Institute of Accountants
- · Member of Engineers Australia, other than at grade of student
- Member of the Parliament of the Commonwealth; or the Parliament of a State; or a Territory Legislature; or a local government
 authority of a State or Territory
- Minister of religion registered under Subdivision A of Division 1 of Part IV of the Marriage Act 1961
- Notary Public
- Permanent employee of the Commonwealth or a Commonwealth authority; or a State or Territory or a State or Territory authority; or a local government authority; with five or more years of continuous service who is not specified in another item in this list
- Permanent employee of the Australian Postal Corporation with five or more years of continuous service who is employed in an
 office supplying postal services to the public
- Person before whom a Statutory Declaration may be made under the law of the State or Territory in which the declaration is
 made
- Police Officer
- Registrar, or Deputy Registrar, of a court
- Senior Executive Service officer of the Commonwealth, or of a State or Territory, or of a Commonwealth, State or Territory
 authority
- · Teacher employed on a full-time basis at a school or tertiary education institution

ANZAC DAY IN DUBBO


A very well attended Dawn Service, at least 500 onlookers, many children and not a sound during the solemn service, then a breakfast at the

- (a) <u>The President</u> <u>Ross Ellis</u>

<u>General</u>

<u>Membership.</u>

If all of the members on our books renew this time, we will have close to 1,000, which demonstrates the strength of 7. But there are still diggers out there who we need to contact and I commend those who continue the search for these men who may need our friendship and support.

<u>Finance.</u>

In accordance with a decision at the last AGM, I have convened a finance committee meeting to prepare guidance for the Executive to prudently manage the funds of the Association. Our Honorary Financial Advisor, Peter Leeson has prepared a position paper for the consideration of this meeting. This brief report will be presented during the Treasurer's Report.

7 RAR the Two Tours of Vietnam.

I am delighted to report that the book has paid for itself and we now have fewer than 400 left. The AWM has purchased 54 of the books and continues to sell them for \$140.00 a copy, which means that there is quite some interest from the general public. There must still be many on the nominal roll of the Battalion who have not seen the book and I ask the Association members to renew their energy in promoting the book to those concerned whenever they come across them.

<u>Phase 3 of the Recording of the History of our Two</u> <u>Tours of Vietnam.</u>

This is to be a DVD and so I am now asking for your Super 8 film or even 35mm film which may have been used by a professional if it is in your possession. I shall promulgate details of the submission dates and address soon, but in the meantime, I ask you not to dust off the film and give it another showing prior to submitting it. The reason is that some film may have deteriorated to the extent where it may need the TLC of an expert.

I have recently received the support of one of the curators of the AWM photo and film library, Patricia Sabine, and she has offered to assist us. Already she has identified some of the film which we will need. I wish to reassure those who own such film that I shall ensure that your film will be returned as soon as I can manage to have it copied professionally. So please help locate any relevant film on the 67/68 and 70/71 Tours.

<u>Seven News</u>

There have been a few suggestions tossed around at Executive meetings and in general conversation with regards to the evolution of our newsletter which Tony spends a huge amount of his time preparing and I know that you will wish to support me in thanking him for his diligence. Inevitably Seven News depends completely on the input from individuals members and State reps and I urge you to continue forwarding anecdotes, photos and poems to Tony for inclusion in the three issues per year he is producing. The cost of production is about \$2,500.00 per edition and you will note that it is also placed on the web site by Kev Gillett. It has been decided to continue to send the hard copy to everyone for now and not ask those who can access the web copy to forego the snail mail copy. The Executive considered the fact that eventually there will be a decline in the number of members of the Association and that the widows will outnumber the members.

In years to come, this will no doubt necessitate the payment of some fee, but until that time is reached, the Association will provide the Seven News to those widows who would like to receive it.

<u>The Pig List.</u>

It is some time now since the Pig List was published. Though there is a clause in the membership renewal form which asks members to give permission for other members to have access to their personal contact details, the Executive has taken a cautious approach to the release of information and the widespread dissemination of the list again.

There are two main reasons for this; First, the information is often out of date within a year of being published : and Second, we need to adhere to current legislation on privacy provisions. So, it has been decided that a couple of contacts in each state will be provided with the list and will be asked to pass information on members to those members who request such details. Information will not be provided to non-members. The list will be updated by the XO on a biannual basis.

The Web Site.

I wish to thank our Web Master, Kev Gillett, for the effort and thoughtfulness with which he maintains our web site. There are no doubt many members who are well versed in web management and I would ask them to forward to Kev any helpful comments they may have on the evolution of web sites as they develop.

I would ask also those who are computer literate to encourage those who are not to gain sufficient basic skills to access the net and send emails. It is now very cheap to access the net through the TADACT scheme, details of which we published in the Seven News recently.

<u>Non-Operational Memorial at 5/7 RAR Robertson</u> <u>Barracks</u>.

The ADF has fostered the erection of this memorial. As a consequence, we have been asked by the Records Sergeant at 5/7 RAR to provide any information we can as a means of assisting him with the cross-checking of those who died as members of 7 RAR while training in a non-operational role. Anyone with any information on the non-operational death of any member of 7 RAR from whatever cause is requested to advise the XO, please.

<u>Roll of Honour at the Regimental Memorial at Martin Place in Sydney.</u>

Both 8 RAR and 9 RAR Associations have now placed rolls of honour on the reverse side of this memorial and I need the guidance of the Association as to whether we should follow suit.

Housing of the Gonfalons of the 7th Battalion AIF, the 2nd 7th and 7 RAR.

The Rev Howard Barnett has indicated that there was an emerging problem of space at the Garrison Chapel and the storage of our gonfalons was becoming a problem, particularly as they were placed in the corner of his office. As a result, I have discussed with him the potential for us to build permanent storage at the chapel. The guidance of this meeting is sought on this matter.

The 2009 Reunion and the 50th Anniversary of the raising of the Battalion.

It has been widely recognised that the time around ANZAC Day is inappropriate for a reunion and planning will take this into account later in this meeting when we decide on future venues for the reunion and the 50th Anniversary of the raising of the Battalion.

Commemorative Plaque at the AWM.


